Dear faculty and staff,

As you are aware, the College recently delayed Phase 3 (Employee Return) of the College's Return to Work Plan. The delay provided an opportunity to review safety measures to ensure all safety protocols are in place. To that end, we are prepared to return Monday, May 25, 2020.

By now, your supervisor should have reached out to you to discuss plans for the office or division in which you work, and they should have provided work expectations. If they have not, you should reach out to them to seek guidance. Please know that the plan is not a full return; however, it is one that will allow staff to return to the office with limited hours and in limited numbers.

In my last communication to you, I indicated that the college is adhering to all safety guidelines by healthcare experts and the Center for Disease Control. There will be mandatory check-in points from 7:30-9:30 a.m. each workday. You will not be allowed to enter the building without going to one of those check-in points, or after the check-in point is closed. Please adhere to these guidelines and understand that your safety and that of others is paramount. At the check-in points, your temperature will be taken and you must complete a wellness form. If your temperature is 100.4 or above, or your responses to the wellness questionnaire do not meet safety requirements, you will not be allowed access to the building and will be referred to Human Resources. The chart below represents the check in points for each campus/site. Please note that not every campus/site will be open every day. As we progress and the state moves to phase 2 of its plan additional check-in points will be added and the times will be extended. I am asking for your patience because this plan is not for a full return but a limited one. The expectation is for those who can work from home with the highest level of productivity to continue to do so.

**A minimal number of students will return to campus starting May 25, 2020, to complete academic requirements, as coordinated by Instructors, Division Deans and the Interim Vice Chancellor for Academic Affairs and College Provost.*
